## CLEANER 10

## Description

Loxeal Cleaner 10 is a non-CFC solvent based formulation for clianing and degreasing of surfaces to be bonded or sealed with Loxeal adhesives or sealants.

#### **Typical Applications**

- Treated surfaces
- Worked surfaces
- Plastics substrates
- Oil/grease contaminated surface
- Surfaces trated with protective coating

Cleaner 10 has no effect on the speed of cure or final strength of Loxeal adhesives and sealants while unclean or partially cleaned can affect negatively on adhesive performances.

## **Directions for use**

- 1. Treat surfaces to be bonded by spraying with Loxeal Cleaner
- 2. Wipe surfaces when still wet with a clean tovel to ensure heavy contamination is removed.
- 3. Allow the solvent time to evaporate until the surfaces are completely dry.
- 4. Apply the adhesive or sealant immediately after drying and assemble bond.

The solvent can affect certain plastic or coatings. It is recommended to sheck all surfaces for compatibility befor use.

## **Handling Precautions**

Cleaner 10 is highly flammable. Special care must be taken to avoid contact of the cleaner or its vapour will naked flame or any electrical equipment that is not flame proofed.

Avoid prolonged or repeated skin contact.

Use only in a well ventilated area.

No smoking in presence of cleaner.

#### Storage

We suggest to store Cleaner 10 in a cold, dry location at a temperature between +5°C to +25°C. At this condition shelf life of Cleaner 10 is 12 months.
